Investigative Process:

• Chief Ferland requested I remotely observe the corner of Michigan and Capitol on Friday June 19, 2020 around 10:17 PM EST via a Michigan Senate issued laptop.

On 06/22/2020 at approximately 1:00 PM EST, I reviewed video surveillance from the Boji – Exterior West PTZ (02) camera.

I immediately created a bookmark in the Genetec Security Desk Monitoring system to document the incident for future review.

- On 06/22/2020 at approximately 10:17:08 PM EST, headlights from two motorcycles traveling south on Capitol Avenue are observed.
- On 06/22/2020 at approximately 10:17:14 PM EST, an unknown white female runs out from the barricades in front of the Capitol and stands in the traffic lane located at Capitol Avenue and Michigan Avenue.
- On 06/22/2020 at approximately 10:17:22 PM EST, an unknown driver of motorcycle hits unknown female and continues south on Capitol Avenue.
- I also protected the video from deletion from the system.

On 06/23/2020 at approximately 9:29 AM EST, copies of the video from Boji – Exterior West PTZ (02) were transferred to Universal Serial Bus (USB) thumb drives for the Michigan State Police and the Lansing Police Department.

    - k. The driver of the motorcycle was identified as Jeffrey Thomas Bush. Bush came forward to LPD when he saw his photograph on Facebook.

- 4. Sprint carrier search warrant request for Jeffrey Bush:
  - a. Jeffrey Bush confirmed (517)712-9402 was his cell phone number. I have contacted Bush several times at (517)712-9402.
  - b. Bush stated he has not been in the Lansing downtown area in 6-8 months. Bush stated he was not downtown during the week of 6/152020 to 6/19/2020. Bush stated he was not downtown prior to the incident circling the block making racist remarks or harassing the demonstrators.
  - Dievondorf stated she is adamant Bush was the same person driving around the block making racist remarks and harassing the demonstrators.
- 5. The question has been raised if this incident was related to a hate crime and if Bush was the same person who was making racist remarks and harassing the demonstrators. Was Dievendorf intentionally hit by Bush due to her being related to a BLM event. Even though at the time of the incident no racial slurs or gestures were made Dievendorf believed that this was the same person who had drove by on 2 previous occasions yelling racial slurs and gestures. Historical call detail records, historical text detail records, IP data records, all with cell tower and sector data including latitude/longitude could provide evidence to determine if Bush was involved in the harassing of the demonstrators or not, whether this is a hate crime or not and to as evidence of a felonious assault.
- C. Based on affiant's training and experience, it is known that mobile communication devices are used to plan, commit, and conceal criminal activity and evidence. Therefore, data obtained from mobile communication devices and records created by these devices can assist law enforcement in establishing the involvement of a possible suspect or suspects.
- D. Records created by mobile communication devices can also assist law enforcement in establishing communication activity/behavior, patterns, anomalies, patterns of life and often the identity of the device user. This is most effectively accomplished by reviewing a larger segment of records ranging prior and after the incident under investigation if possible.
- E. The aforementioned information combined with affiant's training and experience cause her to believe the execution of this search warrant will assist with the furtherance of this criminal investigation.

Cellular Phone Data Extraction and Forensic Analysis Report CASE# 2051906115 Analyst Megan Johnston



#### **INFORMATION:**

I performed a data acquisition and forensic analysis examination of a cellular phone at the request of Detective Shawn Martinez regarding evidence pertaining to a felonious assault investigation. The phone was searched under the authority of consent.

#### DATA ACQUISITION AND FORENSIC ANALYSIS EXAMINATION:

The examination of the phone was conducted using Cellebrite UFED 4PC (v. 7.34.1.23) and Cellebrite Physical/Logical Analyzer (v. 7.35.1.15). The Cellebrite UFED extracts vital data such as phonebook, pictures, videos, text messages, Call History, ESN and IMEI information from 1600+ models of handsets sold worldwide. The Forensic Analyst can subsequently analyze the contents of the cellular phone including stored numbers and text messages. The UFED Physical Analyzer is one of the most advanced analysis, decoding, and reporting applications in the mobile forensic industry. It includes malware analysis, decoding, and reporting applications, project analytics, timeline graph, exporting data detection, enhanced decoding and reporting functions, project analytics, timeline graph, exporting data capabilities and much more. I am currently trained and certified in the use of the Cellebrite system. The Cellebrite UFED and Physical analyzer used are licensed to the Lansing Police Department.

#### **EXTRACTION TYPES:**

LOGICAL: Extracts user data from mobile device (SMS, call logs, pictures, contacts, videos,

audio, certain application data and more)

FILE SYSTEM: Extracts the file system of the device, user data, mobile application data, and possibly hidden files (protected files)

PHYSICAL EXTRACTION: Extracts a bit by bit binary image of the devices flash memory and is able to obtain unallocated space.

#### **BOOTLOADER:**

As used by the Cellebrite, system bootloaders are small pieces of code that are placed on the phones RAM by the UFED. The device begins running the bootloader but does not continue its regular boot procedure to the operating system. The bootloaders then execute a "read only" function that extracts the evidence from the phone.

#### PHONE INFORMATION:

#### DATA EXTRACTION: Samsung

The phone was powered on and unlocked upon receipt of the device. The following settings were made to the phone in order to allow data transfer:

When the phone was connected to the UFED the phone prompted to allow USB debugging, "always allow from this computer" was selected.

Logical and file system extractions were performed.

#### **REPORTING:**

The data from the extraction was analyzed through the physical analyzer. A PDF report of the extraction was created and copied to a disc. The report and phone were turned over to Detective Shawn Martinez.

Hey, all. I am looking for help identifying these two. They mowed me over when I was out making sure "Black Lives Matter" was getting painted on Capitol Ave. in front of the Michigan Capitol Building on Friday night. They are friends with the driver alone on his bike in the other photo. (Hey, that's me landing on the ground.)

They are among the many motor vehicle I have witnessed doing laps around anti-racist demonstrators and BLM supporters over the last few weeks, at high speeds, packing weapons and making threats. This couple had already done a packing threatening gestures and were packing. (I have been out regularly to quietly downtown for weeks with somebody else on the downtown for weeks with somebody else on the more safely and respectful of demonstrator space. Do not attempt it without contacting us to join to contribute.)

On Friday the bike that hit me saw me and sped up at their flashing yellow, braced for impact and simed. I tried to shift and it didn't work. There were two bikes and they kept going even after making impact with my body straight on. I only remember landing.













not welcome. The harassers are visibly armed. Some are so bold that they have circled over and over in convertibles with the top down. How completely sure of your power in society must you have to be to do that? They drive fast enough that it is hard to get their plates.

Friday, we had enough of his circling. I was clearly in view and ready to get plates. He had plenty of time to slow down and I think we always have the choice to not pick up speed and aim our vehicle at another human.

I often say that I am not one to put people into categories of good or bad. I have been working in social justice and civil rights for a long time and it is "hearts and minds work." It is a place where you "meet people where they are" and fill in the blanks. It allows for evolution if not for continued harm. On Friday I did what many people in civil rights have done throughout history, I stood. I let somebody who was being harmful see me. From a distance and as he approached from far away. I have worked on gruesome hate crimes. I know folk dehumanize. Even I didn't expect him to speed up. I always surprise myself when I assume more of people.

I know he saw me because I heard somebody say that after he had already sped up and gotten too close it was then that he said, "Get the fuck out of the road."














So, yes, I do want to find him, but not just him. He is just one of many. And I just happened to be there. I was also just one of many. I was symbolic of so many he wants gone. And that's how bias incidents work. Anybody Black or Brown or believing in the value of Black and Brown Lives could have been in his path and they would have been as insignificant. Nonentities.

And that is white supremacy in a nutshell. The ability to, in a split second, decide somebody's life doesn't matter as much as yours. To feel they don't matter at all. That the hierarchy is THAT clear.

Would the night have been even more dangerous if the group had been all BIPOC?
Absofuckinglutely. I am most grateful that the artist who planned the beautiful piece did not end up harmed as a result of us asking her to help and putting her in harm's way.

Allies need to show up ANYWAY. And without need for thanks. And without anyone working hard to convince us. And without us making up our own agendas. And without our egos getting hurt when we are asked to be patient, or open when we are asked to consider that what we have learned may be wrong. We need to start over knowing it is a risk for us now but it has been for those we are serving from the beginning. It's going to bruise.

Katherine stated she was near the intersection of Capitol / Michigan when the incident occurred. She advised she was with a group of people painting Black Lives Matter with the permission of the Mayor at the intersection. She advised she saw two motorcycles heading southbound on Capitol approaching the intersection. She advised the motorcycles were driving parallel to one another.

Katherine stated the victim (Emily) was standing parallel to one of the orange cones in the intersection. She stated that it looked like Emily was either waiving her arms at the motorcycles to slow down, or waiving her arms towards the camera guy on scene. She stated that a couple people in the group have been taking pictures of anyone that's been harassing them during the Black Lives Matter protests.

Katherine stated that the motorcycle appeared to speed up and it looked as if the driver swerved over to intentionally hit Emily. The accused was last seen heading southbound on Capitol.

#### WITNESS STATEMENT (A. PEARSON):

Abigail stated that the barricades and cones were up at the intersection to block traffic. She stated that the barricades were moving the one lane of traffic over to the eastern most lane. She stated that two motorcycles starting heading southbound on Capitol approaching Michigan Ave.

She advised Emily was standing to the right of the barricade (just parallel to it). She stated that Emily was attempting to get the motorcycles to slow down, but they continued to speed up and drove right towards her. She stated the motorcycle with the W/M driver and W/F passenger was the one that collided into Emily. She stated the motorcycle was black in color and appeared to be a Harley. Last seen heading southbound on Capitol.

#### WITNESS STATEMENT (M. PETERSON):

Michael's statement was very similar to Katherine and Abigail's. He advised the motorcycle that struck Emily was revving his engine and started driving directly towards her. He advised that it was impossible for the motorcycle to not see Emily standing there. He stated it happened near the middle of the intersection of Capitol / Michigan.

#### VICIM STATEMENT:

I made contact with Emily at Sparrow Hospital (1215 E Michigan Ave). She advised she was at Capitol / Michigan painting the Black Lives Matter mural with the permission of the Mayor. She stated throughout the evening, a big Harley motorcycle kept circling the group she was with and harassing them.

Photographs of the accused and motorcycle were put on social media. The driver/accused of the motorcycle, Jeffrey Thomas Bush, learned of the photographs of social media and contacted the police.

I contacted The Romney Building located at 111 S Capitol Ave for a copy of the video. I obtained a copy of the video via flash drive.

I obtained a preservation letter for Jeffrey Bush's Facebook Page. Confirmation #4985020.

#### VICTIM EMILY DIEVENDORF'S STATEMENT:

Dievendorf she runs the White Ally Program. Dievendorf stated her role at the event was to walk quietly around, watching for trouble and collect information of trouble makers to put them in a database as possible problems for future events.

Dievendorf stated she had permission from the Mayor and LPD Chief to paint a mural on Capitol in front of the Capitol Building. Dievendorf stated she and her friend Zachary Whaley were to inform and keep the demonstrators safe. Dievendorf stated she and Whaley would take photographs of people and license plates who were harassing the demonstrators.

Dievendorf stated Capitol had a flashing yellow light and Michigan had a flashing red light. Dievendorf stated the West 2 lanes on Capitol were blocked off by cones so the demonstrators painting the mural. Dievendorf stated the far east 3rd lane and turn lane were open for travel.

Dievendorf stated she was wearing a dark colored running clothes with side reflectors. Dievendorf stated even though it was 2200 hours the area was well lit from being downtown and the street lights.

Dievendorf stated a motorcycle had been harassing demonstrators all week long. Dievendorf stated the motorcyclist would rev his engine, make racial slurs, threats and made sure everyone knew he was carrying a firearm on his hip when he drove by.

Dievendorf stated she got the group together to inform them of shooting that occurred around the corner and that if people wanted to leave that would be ok. Dievendorf stated she just finished her announcement when she heard a motorcycle coming down the road.

Dievendorf stated she motioned to Whaley to get him ready to take photographs. Dievendorf stated she was positive this was the same motorcyclist who had been harassing the demonstrators earlier in the week who had the firearm.

Dievendorf stated she stepped out onto Capitol in the crosswalk to get a photograph of the motorcycle's information as he drove by Dievendorf stated she was not in the coned protected area and in clear view of the motorcyclist. Dievendorf stated she thought the

motorcyclist would acknowledge her and slow down. Dievendorf stated there was plenty of room for the motorcyclist to slow down and to go around her.

Dievendorf stated the motorcyclist accelerated. Dievendorf stated every time she moved in a direction the motorcyclist followed her. Dievendorf stated she tried to get behind the cones when the motorcyclist accelerated, turned toward her and hit her which sent her flying in the air.

Dievendorf stated she tried to get out of the way but the motorcyclist intentionally hit her. Dievendorf stated the motorcyclist followed her, aimed for her, accelerated and intentionally hit her. Dievendorf she tried to move out of the way but the motorcyclist turned toward her and hit her.

Dievendorf stated she felt scared.

#### ADDITIONAL EMILY DIEVENDORF'S STATEMENT:

Dievendorf stated the event started at about 1930 hours. Dievendorf stated she tried to pay attention to what was going on all around. Dievendorf stated this included the mural painting and the people driving by.

Dievendorf stated closer to 2200 hours, the motorcycle harassing the group was a single motorcycle, large, black, Harley Davidson being driven by an U/M, wearing no helmet. Dievendorf could not provide any additional information on the motorcycle or the driver. Dievendorf stated she did not see the firearm on his hip and was told this information by the group. Dievendorf stated the single motorcycle was seen doing laps around the Capitol Building. Dievendorf stated she saw the same motorcycle drive by a few minutes later with a passenger. Dievendorf could not provide a description of the passenger.

Dievendorf stated all the comments she heard was from the group and did not see or hear anything the motorcyclist said or did.

Later Dievendorf stated she saw 2 motorcycles drive North bound Washington at Michigan at a high rate of speed. Dievendorf stated a few minutes later the 2 motorcycles were driving South bound Capitol. Dievendorf stated she knew it was one of the same motorcycle that circled the Capitol harassing the demonstrators because it was a large, black Harley Davidson being driven by an U/M, wearing no helmet.

Dievendorf stated they have no photographs of the motorcycle who harassed the demonstrators.

#### INJURIES/MEDICAL TREATMENT:

Dievendorf was transported to Sparrow Hospital via LFD.

Dievendorf complained of pain all over her body.

I met with Dievendorf a couple of days after the incident. Dievendorf stated she was still stiff and sore all over her body. Dievendorf had road rash, bruises and cuts. Dievendorf did not have any broken bones, internal bleeding or any major injuries. Dievendorf stated she was to self monitor for signs of a concussion since she hit her head on the pavement upon impact on the ground.

Hall stated they were driving down Capital and the 2 most West lanes were coned off. Hall stated he was driving next to Bush in the one open lane. Hall stated he was slightly behind Bush. Hall stated he saw Bush swerve a couple of times in the lane but did not know why. Hall stated they continued down Capitol along their path until they got home.

Hall stated he never saw the female. Hall stated he did not see Bush hit the female.

Hall stated the area was somewhat lit by streetlights.

Hall stated he was driving about 30-35 mph.

Hall stated he found out when they got home that Bush hit someone. Hall stated they did not know what to do.

Hall stated Bush told him he was a CPL holder and that he had taken classes. Hall stated Bush was not carrying his handgun that night.

Hall stated he does not have a handgun and is not a CPL holder.

Hall stated he had not been downtown in awhile and that he is truck driver so he is gone during the day time.

McLeod stated she felt scared as Bush was going left and right trying to avoid the female because she was not wearing a helmet and thought they were going to crash. McLeod stated she just hung on.

McLeod stated Bush did not have a firearm.

McLeod stated she has known Bush for 2 years. McLeod stated Bush is not affiliated with any groups, is not abusive, is not racist.

Kowalk stated he was downtown to paint the mural. Kowalk stated Dievendorf gathered them around to tell about people driving around driving recklessly and were threatening people.

Kowalk stated he heard 2 motorcycles approaching, revving their engines. Kowalk stated Dievendorf quickly grabbed her phone because she wanted to take photographs of the license plates.

Kowalk stated he was standing behind Dievendorf when she stepped toward the barriers. Kowalk stated the motorcycles saw Dievendorf and revved their engines.

Kowalk stated Dievendorf was about one step outside the protected area by cones.

Kowalk stated the motorcycles had plenty of space to move around Dievendorf.

Kowalk stated the motorcycle hit Dievendorf and sped off.

Kowalk stated he heard someone yell something but didn't hear what was said or who said it.

Kowalk estimated the motorcycles driving about 30 mph.

Warner stated Dievendorf was standing outside the barrier in the roadway. Warner stated the motorcycle hit Dievendorf and Dievendorf went flying. Warner stated the motorcycles drove off.

Warner stated she did not recall anyone saying anything prior to, time of or after the incident.

Warner stated the motorcycles were revving their engines the entire time.

Warner stated she did not know how the motorcycle could not have hit Dievendorf on purpose.

Warner stated she thought the motorcycles were going about 35 mph. Warner stated the speed felt too fast for her for it being a barricaded area with people around.

Warner stated she did not see the motorcycle who hit Dievendorf with a firearm.

Steinfield stated she heard engines from a motorcycle. Steinfield stated Dievendorf ran to the edge of the cone area. Bush stated he and his friend, Gerald Hall, met Hall's friend at a bar in Charlotte. Bush stated they arrived at the bar at about 2100 hours. Bush stated he had one beer. Bush stated they left shortly after and drove to Lansing to pick up Jessica McLeod in the north end of Lansing. Bush asked McLeod if there was a protest in downtown Lansing. McLeod told Bush she didn't think so, especially at 2200 hours. Bush stated there were street lights in the area but the area was not very well lit. Bush stated his headlight was in working order and on. Bush stated he and Hall drove next to each other in the lane. Bush stated as he and Hall were driving Southbound a female stepped out into their lane and was motioning at him. Bush stated he swerved a little to the left to avoid the female. Bush stated the female then walked to his left and got in front of his motorcycle. Bush stated he swerved to the right to avoid the female. Bush stated the female walked to his right, got in front of his motorcycle and lowered her shoulder. Bush stated he tried to swerve to the left again to avoid the female and braced for impact. Bush stated he felt the female hit the motorcycle. Bush stated he continued to drive away because he did not want to get assaulted by the protesters.

Bush stated he tried to avoid the female several times but she kept getting in front of his motorcycle. Bush stated he felt the female was trying to get him to wipe out or get hit by his motorcycle.

Bush stated he couldn't do anything more to avoid the accident. Bush stated the road was down to one lane and his friend Hall was in driving next to him. Bush stated he also had to worry about himself and McLeod, who was sitting on the back of his motorcycle, to think about.

Bush stated he was driving at about 30-35 mph. Bush stated he might have accelerated a little bit to keep his motorcycle under control as he was trying to navigate to avoid hitting the female and from dumping his motorcycle.

Bush stated he did not intentionally hit the female and that she kept getting into his path as he moved to avoid hitting her.

Bush stated he left the area not to get assaulted by the protesters. Bush stated he did not know what to do after the fact. Bush stated he was going to call the police on Monday to report the incident but saw photographs of him on social media and called police right away. Bush stated he had one beer at the bar and he was not intoxicated.

#### ADDITIONAL JEFFREY BUSH'S STATEMENT:

Bush stated he does not have a weapons, abuse, drugs or alcohol history.

Bush stated he purchased a firearm in May. Bush stated he has taken classes for a CPL license and will be taking his oath on 6-29-2020.

Bush stated he does not open carry or carry his firearm.

Bush stated he obtained the firearm for home safety. Bush stated he is obtaining his CPL license so he can carry his firearm while he makes money deposits from his work to his bank.

Bush stated he was not carrying his firearm at the time of the incident.

Bush stated he has not been downtown in 6-8 months.

Bush stated he primarily drives his truck. Bush stated he and Hall drive their motorcycles once a week, typically on Wednesday. Bush stated he and Hall were busy on Wednesday and decided to ride on Friday the night of the incident.

Bush stated he and Hall drove to a bar in Charlotte. Bush stated they got their at about 2100 hours. Bush stated they had two beers. Bush stated they left at about 2130 hours. Bush stated he got a text from McLeod.

Bush stated they drove to McLeod's residence which was about a 20-30 drive from Charlotte. Bush stated they drove down Lansing Rd to Canal Rd to Saginaw Rd to North on Seymour.

Bush stated they asked McLeod if there were any protesters downtown. McLeod stated she didn't think so.

Bush stated they drove the path of least resistance. Bush stated they decided to drive South on Capitol Ave to Washington Ave to Holmes Rd to get to Hall's residence.

Bush stated a female stepped out in front of him. Bush stated he tried to avoid the female but she kept getting into his path. Bush stated he had no where to go with cones on one side and Hall on the other side.

Bush stated the female was either trying to get him to dump his motorcycle or get him to hit her. Bush stated the female lowered her shoulder.

Bush stated he did not intentionally hit her. Bush stated he did not make any racial slurs or comments. Bush stated he had not driven around the block harassing them. Bush stated he was not armed.

Bush stated he is an owner/operator of a semi truck. Bush stated he Monday off. Bush stated he worked Tuesday, Wednesday and Thursday from 0500 hours to 1700 hours.

Bush stated he has no affiliations to any hate groups, NRA groups political groups or anything like that. Bush stated he gets on a looks at a chat group called 2 A Group. Bush stated that is a 2nd Amendment chat group in which he just reads people's post. Bush stated he has never posted anything on the post, he just goes there to read.

#### FOLLOW UP:

Bush gave verbal consent to search his Facebook Account Jeff Bush and his cell phone.

I obtained a search warrant for Bush's Facebook Account.

I was unable to find anything in installed apps that was relevant to this case.

I was unable to find any MMS messages relevant to this case. There were no text messages on 6-19-2020. Photos were attached to text messages after the incident from other people to Bush.

I was unable to find any searched items relevant to this case.

I read through the SMS messages from a couple of days prior to the incident to after the incident. Nothing in the messages indicated this was intentional or hate related. Some of the text messages after the incident are on the extraction report pages 513 and 514. Pages 516 and 517 are messages prior to the incident. On 6-19-2020 at 1857 hours (UTC) Bush gets a message from Jerry Hall talking about going to Charlotte to meet some friends. At 2111 hours (UTC) Bush sends a message to Jessica McLeod saying one more beer and will be on his way. At 2128 hours (UTC) Bush sends a message to Jessica McLeod saying he was getting on his bike now and on his way. On 6-21-2020 at about 1705 hours (UTC) Bush receives a Facebook story link from Dan S. This was the first message about the incident since the incident. None of the prior messages appeared to hate, affiliations, groups, associations, racial slurs or crimes related.

The time line of messages starting on 6-2-2020 starts on page 1651. The time line of messages starting on 6-19-2020 starts on page 1678. Applications start on page 1772. None appeared to relevant to this case.

On 6/26/20 at approximately 0800 hours Det. Martinez contacted me as an accident reconstructionist to obtain some measurements and information from a personal injury crash she is investigating. I reviewed the video provided by the Romney Building. I then went to the area of Capital and Michigan and obtained the several measurements.

#### VIDEO:

The Romney video shows an overhead view of the intersection of Capital and Michigan. The video is zoomed into an area of the roadway that was being painted with the saying "black lives matter". The west lane is closed at the intersection with barricades and cones. There are several people inside the coned off area. The video shows a pedestrian exit the coned area and stand in the roadway facing north. The pedestrian stands in the middle travel lane as two motorcyclist approach. The pedestrian side steps both left and right in the roadway with her arms extended outwards until she is struck by one of the motorcycles. The pedestrian if knocked to the road and the motorcycles continue south out of the sight of the video. The area was lit by overhead lighting and it was dark outside.

The intersection of Capital and Michigan normally has three southbound lanes, one way, with an additional left turn lane north of the intersection. There are parallel parking spots on both sides of the road both north and south of the intersection. The area in front of the capital has extended curbs that take up the portion of the parking areas. Michigan does not continue west of Capital making it a "T" intersection. The intersection is controlled by traffic lights and has marked controlled crosswalks. The area has overhead street lighting and is posted 25 miles per hour.

#### MEASURMENTS:

- 1. 45' 7" = west curb to east curb on the south side of northern most crosswalk on Capital.
- 2. 28' 7" = west curb to the area between the ninth and tenth crosswalk dash (west to east) of the south side of the northern most crosswalk on Capital. This was the area the motorcycle was seen on video to be traveling southbound and entering the intersection.
- 3. 52' = south side of the northern crosswalk on Capital to the base of the "V" on black lives matter. This was the area the pedestrian was standing when struck by the motorcycle.
- 4. 97'6" = distance between north and south crosswalks. South side of northern crosswalk to the north side of southern crosswalk.
- 5. 32'2" = west curb to the area between the ninth and tenth dash marks (west to east) on the southern crosswalk on Capital. This is the area the motorcycle left after the collision.
- 6. 39'6" = distance between west and east curb of the southern crosswalk on Capital.
- 7. 16'3" = west curb, southern end, to the east baseline of letters on the road.
- 8. 17' 5" = west curb, northern end, to the east baseline of the letters on the road.

See corresponding diagram. Not to scale. The picture was the most recent Google Earth photo, taken on 7/7/18.

I watched the video provided by the Romney building. I measured the time it took the motorcycle to travel from the southern edge of the northern crosswalk on Capital to the northern edge of the southern crosswalk. I measured this five times and obtained an average time of 2.84 seconds (2.91, 2.96, 2.85, 2.77, 2.75). The distance between the crosswalks is 97.5'. The time, 2.84 seconds, it took the motorcycle to travel the 97.5' puts the motorcycle traveling 23.4 miles per hour (34.33 fps).

With the motorcycle traveling 23.4 miles per hour plus a perception and reaction time the motorcycle would have needed 75.81' (24.33' to stop traveling 23.4 miles per hour plus 51.48' for perception and reaction time of 1.5 seconds, the standard perception reaction time for an alert attentive driver) to stop. This would have taken 2.92 seconds.

I also measured the time the pedestrian entered the travel lane from the same video. I took five measurements (6.22, 6.09, 6.23, 6.10, 6.10) and it averaged to 6.14 seconds that the pedestrian was in the motorcycles travel lane prior to impact.

#### CONCLUSION:

Based on the above measurements I believe the motorcyclist had time to perceive, react and stop his motorcycle prior to the collision with the pedestrian. Another motorcycle was traveling alongside/behind the colliding motorcycle so evasive maneuvers, such as swerve to avoid the pedestrian would not have been feasible. The video does show the motorcycle slightly swerving to the left just prior to and after the collision. I also believe the pedestrian had ample time to avoid the collision and/or utilize the crosswalks and barricaded area provided.



On 06/19/20 at approximately 22:25 hours, I responded to the intersection of N Capitol Ave / W Michigan Ave, City of Lansing, for a hit and run incident involving a motorcycle and pedestrian. I collected several witness statements and collected video surveillance information from the Capitol Building.

WITNESS STATEMENT: (Misti Cook)

Misti Dawn Cook w/f dob:



Misti stated she was near the painted "L" when she saw two motorcycles approach south bound on Capitol towards Michigan Ave. Misti described both motorcycles as Harley style and red/chrome in color. Misti stated the front motorcycle, while in the intersection of Capitol and Michigan, hit the gas and clearly made a hard turn to intentionally hit the victim, Emily. Misti stated there was a passenger on this motorcycle and the passenger almost fell off the back when they hit the gas. Misti stated that both motorcycles then continued south bound on Capitol before turning east bound on an unknown street.

Misti described the front motorcycle as being driven by a white male, middle aged, heavy set in stature, not wearing a helmet, and possibly having facial hair. Misti believed she would be able to recognize him if seen again. Misti described the passenger on the first motorcycle was a white female, middle aged, heavy set in stature, shoulder length hair (possibly blond or gray), with her hair down.

Misti did not describe the driver of the second motorcycle following the first.

Ferrin stated she was near the painted "S" when she saw two motorcycles that were following each other south bound on Capitol approaching Michigan Ave. Ferrin could not describe the style of motorcycles. Ferrin stated that the first motorcycle was driven by a white male who was wearing short sleeves. The passenger on the on first motorcycle was a white female who was also wearing short sleeves. Ferrin stated that it happened very fast and she could not give more description of the suspects and could not see their faces. Ferrin described the second motorcycle as driven by a white male also. Ferrin believed the subjects on the motorcycle may have yelled something at the pedestrians before striking them but could not understand what was said.

James stated that Emily crossed the cone barrier into the south bound traffic lane. James stated that the front motorcycle intentionally came closer to Emily and struck her as she stood in the traffic lane and continued south bound on Capitol. James stated the second motorcycle followed the first but did not strike any pedestrians. James couldn't hear the accused subjects yell anything.

James described the accused driver of the first motorcycle as a white male, approximately 40 years old, mid length hair, and heavy set in stature. James could not describe the second passenger on the first motorcycle. James did not describe the driver of the second motorcycle.

On Sunday June 21, 2020 at approximately 1809 hours I, (Officer D. Rudd) was dispatched to 6052 Selfridge Blvd in reference to the accused turning himself in for an incident that occurred on June 19, 2020.

## ACCUSED STATEMENT: Jeffrey Thomas Bush

Upon my arrival, I made contact with Jeffrey. On Friday June 19, 2020 at approximately 2000 hours, Jeffrey and his friend Gerald were riding separate motorcycles to pick up his friend Jessica who lives off of Seymour street. Jeffrey stated he asked Jessica prior to leaving her residence if there were any protests going on downtown tonight. Jeffrey told me Jessica said there were not any protests today. Jeffrey, Jessica and Gerald headed downtown to travel back to south Lansing. Jeffrey said he noticed several traffic cones and a barrier as they were heading South on N. Capitol Avenue. Jeffrey saw several people outside near the traffic cones. Jeffrey stated he saw a female approaching the roadway on Capitol Avenue. Jeffrey slowed down to swerve in his lane to the right in an attempt to not hit the female or Gerald, who was riding beside him to his left. When Jeffrey saw the female step further into the roadway he swerved to the left. Jeffrey stated he saw the female step a different direction in the roadway so he swerved to the right to avoid hitting her and the traffic cones on the other side. Jeffrey stated he felt his motorcycle clip the female. Jeffrey stated his right mirror struck the female in the area of her arm. Clinical history: Bilateral knee pain, swelling, bruising. Hit by motorcycle June 20, 2020.

Comparison: No available comparison left knee imaging.

Technique: Axial, sagittal, and coronal proton density. Sagittal and coronal fat-suppressed T2. Coronal T1.

Findings:

#### Marrow:

Moderate range bone marrow edema centered within the medial patella, in part adjacent to medial patellofemoral retinacular/ligament complex attachment. This is in keeping with at least bone contusion/impaction. Small thin associated component of cortical fracture not excludable by MRI. Regardless, no displaced fracture.

#### Joint Fluid:

Small volume of joint fluid without sizable joint effusion.

- Patellofemoral alignment: Within normal limits.

Small indistinct associated partial thickness cartilage defect in this region measuring about 5 mm. No subchondral signal abnormalities.
- Medial Compartment: 3 mm greatest dimension size range high-grade partial-thickness cartilage defect along a portion of the weightbearing medial femoral condyle, superimposed upon a segment of chondral softening and indistinct fibrillation and fissures along at least 10 mm greatest dimension segment of mid to inner weightbearing medial femoral condyle, without subchondral signal abnormalities. Mostly scattered early chondrosis elsewhere.
- Patellofemoral Compartment: Cartilage fissures and perhaps small shallow partial-thickness defect along a slightly less than 10 mm transverse dimension segment of the medial patella. Mostly some chondral softening and indistinct fibrillation/fissures elsewhere.
